DECISION ON YOUR REGISTRATION UNDER REGULATION (EC) NO 1907/2006

Dear Sir/Madam.

In accordance with Article 20(2) of Regulation (EC) No 1907/2006 ("the REACH Regulation"), the European Chemicals Agency (ECHA) has concluded the completeness check of your registration dossier for Slags, steelmaking, elec. furnace (carbon steel production). This registration by Alfa Acciai S.p.A. includes:



In this case, before proceeding with an update dossier you have to export from REACH-IT the EC entry that has been created and import it into your IUCLID installation inventory. Failure to do so will result in your dossier being automatically rejected by the system. Please also be aware that, in accordance with Article 119 of the REACH Regulation, certain information from this registration dossier will be published in the Dissemination Portal on the ECHA website without further notice.
